## **Participation**

GFSI CONFERENCE

The event will take place in Barcelona at the **International Barcelona Convention Center**, 11-14 Plaça de Willy Brandt 08019 Barcelona in Spain or, if the event cannot be held in person for sanitary reasons, the event will be held digitally. In this context, registration fees for in-person event will be swapped to registrations fees for digital event and GFSI will reimburse the difference.

The event includes all plenary sessions, breakouts, coffee breaks, two lunches and one cocktail and, in case the event must go virtual, all additional license and additional organisation fees. You will also have access to the app which will allow you to interact with participants connected digitally and access the participants list.

Please note that due to the Covid-19 pandemic and new laws involving indoor events and activities, a Pass Sanitaire (health pass) is required to attend the in-person event. Passes can be digital or in paper form. They include a QR code that will be scanned on entry into the venue. **Those without the pass will be denied entry.** More info about COVID-19 in Spain is on the <u>Spanish government website</u>.

## **Cancellation Policy for In-person Event**

For cancellations received by the GFSI Conference Registrations Team in writing:

- Before 17th December 2021: The full registration fees will be refunded.
- Between 18th December 2021 and 28th February 2022: 50% of the paid registration fees will be refunded.
- As of 1st March: There will be no refund possible.

The substitution of a colleague from the same organisation is possible at no extra cost provided the GFSI Conference Registrations Team is informed in writing.

Above cancellation fees apply to all registrations received - regardless of payment status.
