Cancellation Policy

For cancellations received by the GFSI Conference Registrations Team in writing:

- Before 23rd February 2023: The full registration fees will be refunded.
- Between 24th February 2023 and 23rd March 2023: 50% of the paid registration fees will be refunded.
- As of 24th March 2023: No refund will be possible. 100% of the registration fee will be retained.
