General Conditions

Please note attendance is strictly limited to members of The Consumer Goods Forum (CGF). The CGF reserves the right to limit the number of delegates per company who attend the Global Summit.

Registration Fees

Summit delegate: 3,290 € excl. tax*

The registration fee includes the Special Sessions, all plenary sessions, two lunches, one Official Cocktail, all refreshment breaks and the Opening Gala Dinner. Registration fees do not include travel or accommodation.

Store Tour Programme: 890 € excl. tax*

The Tour will take place on Tuesday 10th of June. There are a limited number of seats, registrations are on a first-come, first-served basis. The Store Tour is open to registered Global Summit delegates only.

Spouse/ Life Partner: 690 € excl. tax*

The registration fee includes the opening and closing of the Global Summit, the Official Cocktail and the Gala Dinner. Registration fees do not include travel or accommodation.

FLP Participant : 1,700€ excl. tax

The registration fee includes the Special Sessions, all plenary sessions, two lunches, one Official Cocktail, all refreshment breaks, the Opening Gala Dinner, and the Store Tour. Registration fees do not include travel or accommodation.

Payment

Payment of the registration fee should be made in Euros to The Consumer Goods Forum.

A bank transfer payment is possible until 30th May 2025.

Registration is a two-step process:

Cancellation Policy

For cancellations received by the Summit Registrations Team in writing:

- Before 5th May 2025: The fully paid registration fee will be refunded.
- Between 5th May and 16th May 2025: 50% of the paid registration fee will be refunded, and 50% will be retained.
- After 17th May 2025: No refunds will be made. 100% of the registration fee will be retained.

The substitution of a colleague from the same organisation is possible at no extra cost, provided the Global Summit Registration Team is informed in writing.

Professional Engagement Standards

Consultants are kindly asked to refrain from engaging in recruitment activities for specific positions during the Summit, including within Summit venues and official events, such as the L'Oréal Gala Dinner.

Respectful Networking Practices

Interactions should remain professional and aligned with the Summit's purpose, avoiding any behavior that might be perceived as overly persistent or intrusive.

Data Processing

The information requested in this registration form is necessary to complete your registration for the Event. The ticketing and registration process is managed by Evenium SA. Please be advised that if you create an account on [Evenium.net](https://www.evenium.net) or utilise third-party networking tools during the Event, your data will be processed in accordance with the privacy policies of those respective providers.

Purposes and Legal Basis for Data Processing

Certain personal data, specifically your name, company affiliation, position, and email address, collected by Evenium SA shall be shared with The Consumer Goods Forum ("CGF") and its duly authorised subcontractors. This data processing is conducted solely to facilitate your registration for the Event, organise logistical arrangements, provide pertinent materials and information, and communicate with you about future events of a similar nature. The legal basis for such data processing is the necessity of performance under a contract, specifically your participation in the Event. Personal data collected pursuant to the purposes stated herein shall be retained only as long as is strictly necessary to fulfil those purposes or as otherwise required by applicable law.

Your Rights as a Data Subject

Pursuant to the General Data Protection Regulation ("GDPR"), you possess the right to access, correct, delete, or restrict the processing of your personal data, as well as the right to object to certain processing activities.
