Payment

Registrations are a two-step process:

Cancellation Policy

For cancellations received in writing by the GFSI Conference Registrations Team:

- Before 6th February 2026: The full registration fees will be refunded.

- As of 21st February 2026: No refund will be possible. 100 % registration fee will be retained.
